FSSAI has been established under Food Safety & Standards Act, 2006 which consolidates various acts & orders that have hitherto handled food related issues in various Ministries & Departments. FSSAI has been created for laying down scientific and logical standards for articles of Food and to regulate their manufacture, storage, distribution and sale to ensure availability of safe & healthy food for Human consumption across the nation.

The new regulation lays emphasis on ensuring corrective action through self regulation, Premises where public is admitted for repose or for consumption of any food & drink or any place where cooked food is sold or prepared for sale come under the gamut of this Act.



FSSAI has been implemented on 5th August, 2011 and with the implementation of this Act, it becomes obligatory on all food business operators to acquire license under this Act either before the expiry of their existing license or by **5th August, 2012**, whichever is earlier.

**The processing of license takes 60 days.** Therefore, the license should be applied by 5th June, 2012 ( 60 days prior to the due date of obtaining the license/ renewal of license).
