Subject: Consumer Price Index for Industries in Delhi

Dear Sir/Madam,

As per Delhi Administration information, we furnish below the details of Consumer Price Index as applicable under different Base Years.

Base Year 1939

It is increased from 44286 (December, 2022) to 44459 (June, 2023) an addition of 173 points.

Base Year 1960

It is increased from 10100 (December, 2022) to 10139 (June, 2023) an addition of 39 points.

1. In accordance with the wage board recommendation, the DA may be calculated @Re.1/- per every 10 points with base year 1939. On this basis the DA stands **increased** by **Rs.17** w.e.f. 01.07.2023.
2. In accordance with the settlement dated 7.8.1982 increase/decrease of DA is to be calculated @ Rs.1.50 per 10 points in case of 'C' class hotels and restaurant establishment and Rs.2.00 in case of 'A' and 'B' class establishments with base year 1939. Accordingly DA to workman concerned may be **increased** by **Rs.26** in 'C' class establishment and **Rs.35** in 'A' and 'B' class establishments' w.e.f. 01.07.2023.
3. In accordance with settlement dated 8.9.1993 with the Hotel Mazdoor Union, the DA is to be calculated @ Rs.2.00 per point with base year 1960. As such for 'A' 'B' and 'C' class establishments, it works out to an **increase of Rs.78** w.e.f. 01.07.2023.

Members who have arrived at settlement with their workers on different basis may calculate accordingly.
